Conditions of Enrolment

The applicant:

- understands and accepts the terms of SPC Group's refund policy;

- understands that she/he will be tested on commencement of the course and placed in a class at the appropriate English language level;
- understands that she/he must complete all class work, assignments, activities and assessments in order to maintain satisfactory progress;
- understands that she/he must attend at least 80% of the course, and failing to do so will result in him/her being reported to the Australian Government (student visa holders onlu):
- understands that she/he must maintain approved accommodation arrangements and health
- understands that there cannot be a change of school during the course without a written letter of release from SPC Group;
- has read the SPC Group policies and agrees to abide them:
- is aware that school-aged dependants accompanying him/her will be required to pay full fees at a private or government school in Australia
- understands that information collected before and during enrolment is done to meet $\ensuremath{\mathsf{SPC}}$ Group's obligations under the ESOS Act and the National Code 2007 as well as ensuring student compliance with the conditions of their visas and their obligations under Australian immigration laws generally. The authority to collect this information is contained in the Education Services for Overseas Students Act 2000 amended 2012, the Education Services for Overseas Students Regulations 2001 and the National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students 2007. SPC Group Tuition Refund Policy & Guarantee

The enrolment fee is not refundable.

For General English, IELTS and Cambridge Preparation Programs

For cancellation notice given:

- at least 14 days prior to the commencement of the course, you will be refunded tuition fees and OSHC fees.
- less than 14 days prior, on or after the commencement of the course, no tuition fees will be refunded.
- due to visa refusal, tuition fees, OSHC fees and accommodation fees will be refunded as per sections 28-29 of the ESOS Act providing that proof of visa rejection has been provided to SPC

For Specialty Programs

- Any changes must be made at least 6 weeks prior to the commencement by writing to SPC Administration/Staff.
- \$500 administration fee is not refundable.

For cancellation notice given:

- more than 14 days but less than 28 days prior to the program commencement date, you can be refunded 80% of total fee after \$ 500 admin fee is deducted.
- 2 weeks or less prior to the program commencement date, you will not receive any refund of

For Volunteer and Hotel Internship Programs

For cancellation notice given:

- more than 28 days prior to the commencement of the program, 60% of the Volunteer Placement fee will be refunded.
- less than 28 days prior to the commencement of the program, you will not receive any refund of the placement fees.

No refund of tuition fees will be made where your enrolment is cancelled for any such reasons, international bank transfer fees are paid by the student. including but, not limited to the following:

- Failure to maintain satisfactory course progress or attendance
- Failure to maintain approved accommodation arrangements and health cover
- Failure to adhere to the discipline code of SPC Group. This includes behaviour that affects the security of other students, for example, inviting outsiders into SPC Group without permission, this Changes, Cancellation & Refund Policy will apply. or possessing or consuming alcohol on the premises.

In the unlikely event that SPC Group is unable to deliver your course in full, you may be offered a refund. Alternatively, you may be offered enrolment in an alternative course by SPC Group at no extra cost to you. You have the right to choose whether you would prefer a full refund of course fees, or to accept a place in another course. If SPC Group is unable to provide a refund or place you in an alternative course, the Australian Government provides an International Student Tuition Protection Service (TPS).

This will provide a refund of the tuition fees for courses that you have not received or a partial refund for courses that you have partly received. The refund amount is calculated by the TPS Director.

Applications for refunds must be received by SPC Group in writing, addressed to the Director, SPC Group. If you enrolled through an education agent, the fees will be refunded to that agent. This agreement, and the availability of complaints and appeals processes, does not circumscribe your right to pursue other legal remedies nor does this agreement remove your right to take action under Australia's consumer protection laws. If you are concerned about the actions of SPC Group you may approach the State Authority for CRICOS Registration. In Queensland this is the Department of Education. Concerns about the product of the college should be addressed to The Senior Education Officer, Office of Non-State Education, Queensland Department of Education, PO Box 15033, City East, Brisbane, QLD 4002. Complaints must be made in writing.

SPC Group Deferral, Suspension & Cancellation Policy

The decision to defer commencement of studies or suspend an enrolment can be made by the Director of Studies. Students wishing to defer the commencement of their studies or cancel their studies must fill out the Enrolment Amendement Form at reception. The application will be returned once signed and approved by SPC Group. Students are recommended to keep a copy of the document for future references.

SPC Group may consider any suspension of a student's enroment if SPC Group is satisfied that such circumstances exist and that are beyond the control of the student which include life threatening illness or death. Proof of the above must be provided.

SPC Group has a discretion whether to suspend a student's enrolment in response to poor/illegal behaviour etc etc or for any other reason it considers necessary.

The event of deferral or suspension of an enrolment will be reported to DIAC and may affect the status of their student visa.

If SPC Group decides to suspend a student visa enrolment where it is not at student's request, the student will have 20 working days to appeal to the SPC Group. If the appeal is not upheld or the student withdraws from the appeal process then SPC Group will report the student to DIAC. The suspension of the student's enrolment cannot take effect until the appeal process is completed unless there are extenuating circumstances relating to the student's welfare.

The appeal must be submitted in writing and addressed to the Student Services Officer. It will then be brought to the management of SPC. The appeal may take up to 60 days and during this time, appellant will be updated in writing before the final decision arrives.

Student initiated deferral or cancellation of enrolment cannot be granted retrospectively or if it was taken by the student without authorisation.

If students have taken unauthorised leave, they will be recorded as absent and will have their enrolment cancelled if their attendance falls below the student visa requirements.

If a student is unhappy with any stage of the process to defer or cancel enrolment, suspension, they should follow the SPC Group Complaints Procedure, available on SPC Group Orientation Handbook, given to students on their first day at the college.

SPC Group Accommodation Changes, Cancellation & Refund Policy

This policy applies to any student who:

- Is currently in SPC accommodation, or
- Has SPC accommodation booked and commencing (check-in date) in 2 weeks or less.

Two full weeks notice: if you have booked SPC Accommodation (Dormitory and/or Homestay) and you cancel this accommodation you must give more than two full weeks notice to receive any refund. A "full week" is calculated from the day of your arrival. For example, if you arrive on a Saturday, a full week is the following Saturday (8 days, 7 nights). Once the week has commenced, this is not included in the "two full weeks notice".

Changing accommodation: moving from Dormitory to Homestay or vice-versa is considered a cancellation of the Dormitory and a new booking for Homestay.

Changes, Cancellation and Refund Policy is as follows:

- The accommodation placement fee is not refundable.
- Accommodation refunds can only be requested through Enrolment Amendment Form during regular office hours and in writing.

For cancellation notice given:

- 2 weeks or less, you will not receive any refund.
- more than 2 weeks, refund is 80% of the accommodation fee you have paid.
- Note that fees are dependent on exchange rates and can vary from day to day and any
- Refund will take up to 30 calendar days.
- If you break any of the rules, you may be asked to leave the school. In this case, your accommodation is automatically cancelled and there will be no refund of accommodation fees.
